## ORDER

The Madhya Pradesh State Judicial Academy, High Court of M.P., Jabalpur is conducting Advance Course for Additional District Judges (promoted in the year 2015) from 11.05.2015 & 15.05.2015 in the Academy. Additional District Judges, whose names and postings figure in the endorsement, are directed to attend the aforesaid course.

Conditions for the course:

- 1. Barring exceptional circumstances, the participants nominated for the Workshop shall not pray for adjustment.
- 2. The participants shall report by **9.30 a.m.** on **11.05.2015** in the Lecture Room of Madhya Pradesh State Judicial Academy, Jabalpur.
- 3. The participants shall come soberly dressed during entire duration of the Course.
- 4. The participants shall send one copy each of the following to the Academy sufficiently in advance i.e. latest by 27<sup>th</sup> April, 2015 and shall also bring the duplicate of the same with them while attending the Refresher Course:
  - (i) Judgment in Sessions case (contested)
  - (ii) Judgment in Civil Suit (contested)
  - (iii) Judgment in regular Civil Appeal
  - (iv) Judgment in criminal Appeal
  - (v) Order in Criminal Revision
  - (vi) Order/Award passed in Motor Accident Claim case
  - (vii) Judgment/order passed in cases relating to matrimonial disputes.
- 5. The participants may send legal problems which they want to be addressed during the course to the Academy by fax (No. 0761-2628679) sufficiently in advance.
- 6. The participants may bring Laptop Computers or external storage device with them if they find it beneficial.
- 7. The Academy shall endeavour to make best possible arrangements for reception, lodging, boarding and entertainment of the participants in the Guest House of the Academy. The Academy shall make arrangement for their conveyance from the Railway Station to Academy.
