

2. Saturdays falling on 19<sup>th</sup> January, 16<sup>th</sup> February, 16<sup>th</sup> March, 20<sup>th</sup> April, 18<sup>th</sup> May, 15<sup>th</sup> June, 20<sup>th</sup> July, 17<sup>th</sup> August, 21<sup>st</sup> September, 19<sup>th</sup> October, 16<sup>th</sup> November, 21<sup>st</sup> December will be closed Saturdays for Subordinate Court.
3. Summer Vacation of Subordinate Court shall be from 20<sup>th</sup> May 2019 to 14<sup>th</sup> June, 2019 and Winter Vacation from 23<sup>rd</sup> December 2019 to 31<sup>st</sup> December, 2019.
4. Subordinate Courts will not observe the holidays declared or changed suddenly by the State Government/Competent Authority without approval of High Court.
5. The District Judge of the concerned district shall declare three Local holidays declared by the Collector/Commissioner of the concerned District or Tehsil without approval of the High Court under intimation to this Registry.
