2. Saturdays falling on 20th January, 17th February, 17th March, 21st April, 19th May, 16th June, 21st July, 18th August, 15th September, 20th October, 17th November, 15th December will be closed Saturdays for Subordinate Court.
3. Summer Vacation of Subordinate Court shall be from 21st May 2018 to 15th June, 2018 and Winter Vacation from 24th December 2018 to 31st December, 2018.
4. Subordinate Courts will not observe the holidays declared or changed suddenly by the State Government/Competent Authority without approval of High Court.

6. The holidays in respect of Id-ul-Fitar, Id-ul-Zuha, Moharrum and Id-milad un-Nabi are subject to change depending upon the visibility of moon.
