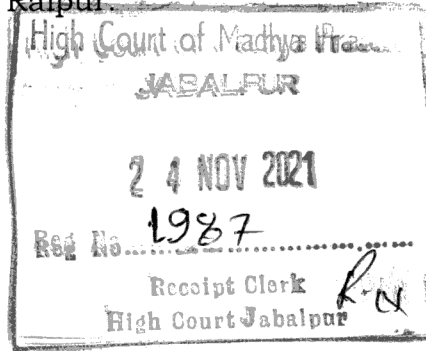

S.O. 4743(E).—In exercise of the powers conferred by sub-section (1) of Section 11 of the National Investigation Agency Act, 2008, (34 of 2008) read with the National Investigation Agency (Amendment) Act, 2019, (No. 16 of 2019), and in supersession of notification number S.O. 2151 (E), dated 1st September, 2010, except in respect of things done or omitted to be done before such supersession, the Central Government hereby notifies the Court of XXIV ASJ (Additional Session Judge), Bhopal, as the Special Court for the purposes of the said sub-section (1) of Section 11 of the said Act for the trial of Scheduled Offences.

2. The jurisdiction of the Special Court mentioned above shall extend throughout the State of Madhya Pradesh.
