2. Saturdays falling on 15th January, 19th February, 19th March, 16th April, 21st May, 18th June, 16th July, 20th August, 17th September, 15th October, 19th November, 17th December will be closed Saturdays of Subordinate Court.
3. Summer Vacation of Subordinate Court shall be from 16th May 2022 to 10th June, 2022 and Winter Vacation from 22nd December 2022 to 31st December, 2022.
4. Subordinate Courts will not observe the holidays declared or changed suddenly by the State Government/Competent Authority without approval of High Court.
5. The District Judge of the concerned district shall declare three Local holidays declared by the Collector/Commissioner of the concerned District or Tehsil without approval of the High Court under intimation to this Registry.
6. The holidays in respect of Id-ul-Fitar, Id-ul-Zuha, Moharrum and Id-milad un-Nabi are subject to change depending upon the visibility of moon.
