

The Secretary of the concerned Committee shall ascertain the time and venue of the meeting scheduled to be held as per Calendar from the available Senior Most Judge of the Committee before convening the meeting. The dates are liable to be changed in case of Administrative Exigencies with prior approval.
- 5. In cases of Administrative Exigencies, the Secretary of the Committee may request the available Senior Most Judge of the respective Committee, to assign a date for convening a meeting on any other unscheduled date in addition, so that urgent and important matters are not held-up for want of dates of the meeting.
