 - after the General Transfer Exercise, if there is any change in place of posting of nominated Judicial Officers, it will not affect the compliance of the order and the nominated Judges are directed to attend the Course accordingly.
 - the participants need not to submit any Course fee for attending the aforesaid Courses.
 - the participants shall draw their TA/ DA from their respective headquarters as per rules.
 - the participants shall be accommodated in NFSU, New Delhi on single occupancy basis.
 - to send comments/ suggestions regarding experience of Course to the Director, MPSJA, Jabalpur.
 - to intimate the Registry after attending the Course.
