  - to send their travel itinerary to the Academy well in advance via email at dirmpsja@mp.gov.in.

- the Guest House of the Academy will be available from 3:00 p.m. of the preceding day until the morning of succeeding day of the Course.
- as per rules, judicial officers are permitted to bring their children up to the age of five years with them during the training period.
- duly filled in Registration form shall be positively submitted by the participant Judges on their arrival in the Academy.
