OFFICE MEMORANDUM

Subject: Training to Judicial Officers on various topics related to cyber crime and forensics by I4C, MHA - reg.

The Indian Cyber Crime Coordination Centre (I4C) has been set up under the Ministry of Home Affairs to provide a framework and ecosystem for Law Enforcement Agencies (LEAs) to deal with cyber crimes in a coordinated and comprehensive manner. I4C aims to enhance the capabilities to tackle cyber crimes and to develop, maintain and improve coordination architecture with LEAs.

2. One of the components of the scheme is the National Cyber Crime Ecosystem Management which develops ecosystem that bring together academia, Industry and Government to operate, investigate cyber crimes based on established Standard Operating Procedures, contain the impact of cyber crimes and respond to cyber crimes.

3. To supplement the efforts of States/UTs for prevention of cyber crimes and to enhance the capacity of Judicial Officers, training programs for Judicial Officers are being organized at different venues by thge I4C, the details of which are as under: -
