  - the participant Judges shall not seek exemption except in case of vis major. Under such a circumstance, the application shall be forwarded to the MPSJA after due examination/ verification from the respective Principal District Judge accompanied with their report.

  - duly filled in Registration form shall be positively submitted by the participant Judges on their arrival in the Academy.
