Sub: A Two Days Seminar on 'Speedy Trial & Efficient Prosecution' is scheduled to be organised by S.V.P. National Police Academy, Hyderabad from May 05-06, 2022 - Inviting nominations - Reg.

Madam/Sir,

A Two Days Seminar on '**Speedy Trial & Efficient Prosecution**' is scheduled to be organised by S.V.P. National Academy, Hyderabad from May 05-06, 2022 for the officers of the rank of Additional Superintendent of Police to Inspector General of Police, Officers from Prosecution and Officers from Judiciary.

2. The objectives of the Seminar are:-

- i. To discuss and apprise the officers about amendments required in procedural and substantive laws for the speedy and effective disposal of cases, especially in the light of suggestions sought by Ministry of Home Affairs, from all the States, regarding amendments in Criminal Statutes.
- ii. To encourage widespread awareness and understanding about the latest processes being incorporated in CIS system, integration of ICJS, CIS and CCTNS and the latest initiatives being undertaken by E - Committee of Supreme Court.
- iii. To sensitize the police officials in understanding the bottlenecks in justice delivery system and how they can be removed by coordinated efforts in areas (a) Service process including the latest digital platforms like WhatsApp, email; (b) Adjournments; (c) Interlocutory orders; and (d) Appearance and examination of witnesses and accused through video conferencing.
- iv. To make Legal Aid, Plea Bargaining, Camp Courts, Alternative Dispute Resolutions a reality in Criminal Justice Delivery System.
- v. Understanding the application of Pre-Trial Conference, Splitting of Trial, Stages mandatorily requiring the presence of accused and where it can be dispensed with.
- vi. Discussing the best practices being followed in other States for speedy disposal of cases.
- vii. Learning the effectiveness of usage of provisions regarding withdrawal of cases by prosecution to reduce the pendency.
- viii. At the end of the Seminar all the recommendations would be compiled and submitted to Ministry of Home Affairs with a request to circulate the same to the States for their views for effective implementation.

3. Hon'ble Union Home Minister in his last visit to the Academy had emphasized on the importance of "**Speedy Trial and Efficient Prosecution**", accordingly this Seminar has been organized.

4. It is requested to nominate **three eligible officers** of the rank of **Addl. SP to IG** from each State/UT to attend the Seminar. Officers associated with Trial Monitoring should preferably be nominated.

5. Office of the Chief Secretary is requested to kindly forward this letter to concerned department that deals with prosecution in State. We will be grateful if contact details of the nodal officer of concerned department are shared.

6. The Principal Secretaries, Home Department are requested to nominate **two Senior Public Prosecutors, Deputy Director/Joint Director/Director of Prosecution** for the Seminar.

7. The Registrar General of all State High Courts are also requested to kindly nominate **three judicial officers**.
