The police personnel, especially the lady officers who are involved in handling of sexual assault cases, medical officers & the forensic scientists form critical link in successful investigation and prosecution of sexual assault cases.

02 The LNJN National Institute of Criminology and Forensic Science will be organizing training Courses on **Forensic Examination of Sexual Assault Cases** for various criminal justice functionaries including government medical officers (who are involved in medico-legal examination in Sexual Offence Cases), police officers (Dy.SP/ACP and Above), prosecution officers, judges/magistrate and forensic scientists of the rank of SSO and above working in various Central/State forensic science laboratories of the country. 
