In regard to the subject and reference cited above, as directed, I am to state that it has been noticed/brought to the notice of the Registry that the Establishments of various District Courts in the State of Madhya Pradesh are not providing Government accommodations to the Judges, who have recently been transferred to various Family Court Establishments in the State of Madhya Pradesh by the above referred order.

Therefore, as directed, the following instructions have been issued for allotment of Government Accommodations:-

- (1) That the Judicial Officers, who have been posted recently in Family Courts, at the same station, be allowed to continue in the same accommodation, which they have been occupying prior to their posting in the Family Court;
- (2) That in case of Judicial Officers/Judges of Family Court, Labour Court, Consumer Forum, etc., who are arriving on transfer from other station, they may be allotted the Government accommodations of Judicial Pool, if available, as per their seniority;
- That in case of non-availability of the Government accommodations of Judicial Pool, efforts shall be made for allotment of Government accommodations of the GAD Pool, if available, as per their seniority and in case of unavailability of GAD Pool accommodations such Judicial Officers shall be permitted to hire private accommodations on rent as per the policy framed by the Registry in this regard.
