The process fee for ordinary process shall be payable at the flat rate of Rs.100/- per main case, irrespective of any number of Respondent/Non-Applicant but in case of process by registered post or speed post or courier, postal charges shall be paid by the party".

- 3A. If an application in respect of cross-case, if any, under section 438 of the Code of Criminal Procedure for bail is pending before of decided by the Supreme Court, any High Court or any Court Subordinate to a High Court, the particular thereof.
- 3B. (Where the number of accused persons is more than one),
