Hon'ble the Chief Justice vide order dated: 28.01.2022 has been pleased to permit Judges of the District Judiciary and Registry officers of the High Court to avail the facility of fiber optic internet broad band connection at their residence office from any private vendors / service provider like AIRTEL, JIO, VI etc. of their choice within prescribed financial limit of monthly rental plan of Rs. 799/- (+GST) (which is equivalent to existing plan of M/s BSNL Ltd.) in place of M/s BSNL fiber optic connectivity / internet broad plan(if required).

Also, the Judges of District Judiciary (DJ, CJ-I and CJ-II) have been permitted to avail the facility of fiber optic internet broad band connection at their court chamber from any private vendor like **AIRTEL**, **JIO**, **VI** etc. of their choice within prescribed financial limit of their category / designation monthly rental plan of Rs. **599**/- (+GST) (which is equivalent to existing plan of M/s BSNL Ltd.) in place of M/s BSNL fiber optical connectivity / internet broad plan(if required).

The Principal District and Sessions Judges of District Courts and Principal Judges of Family Courts have also been permitted to avail the facility of fiber optic internet broad band connection at their court office from any private vendors / service provider like AIRTEL, JIO, VI etc. of their choice within prescribed financial limit of monthly rental plan of Rs. 799/- (+GST) (which is equivalent to existing plan of M/s BSNL Ltd.) in place of M/s BSNL fiber optical connectivity / internet broad plan (if required).
