
It is being observed that the newly appointed officers/employees of the High Court of Madhya Pradesh very often proceed to their hometown in weekends or otherwise without prior sanction of leave and permission to leave the headquarter, due to which the Registry of the Principal Seat and Benches of the High Court are facing inconvenience in routine functioning and the work is being affected adversely.

In order to curb this tendency of the probationers/new entrants it is directed that they will not avail leave or leave their headquarters without obtaining prior permission/sanction.

It is further directed that all such matters pertaining to leave or for leaving headquarter of the probationers/new entrants shall be forwarded to the Registry of the Principal Seat of the High Court at Jabalpur. It is also made clear that no probationers/new entrants shall leave the headquarters or proceed on leave without prior written permission/sanction of the Registry

This order shall come into force with immediate effect.
