Shri Om Prakash Lavwanshi, Peon/Court Attendant, High Court of M.P., Jabalpur, is allotted High Court Pool Quarter No. "I-242", Shankar Shah Nagar, Jabalpur for his residence on following terms & conditions:-

- 1 If, any employee refuses to occupy the Govt. accommodation allotted to him/her, the name of such employee will be deleted from waiting list;
- 2 If, any employee fails to occupy the quarter, physically, within a period of seven days from the date of present order, then the allotment of the Govt. accommodation shall stand cancelled.
- 3 If, it is found at any time any employee is himself not living in the allotted Govt. accommodation and instead permitted to occupy the same to some other party, then the allotment of accommodation shall be cancelled immediately.
- 4 In any case & under any circumstances, subletting of the allotted Govt. accommodation will not be allowed.
5. If, it is found, at any time, that an employee, owns residential house in the limit of Municipal Corporation, Jabalpur either in his/her name or in the name of any member of his/her family, prior to taking over or after taking over of the occupation of the allotted Government Residential Accommodation, then the allotment of such accommodation shall be cancelled immediately.


