In supersession of the Registry Order No. B/1490/V-3-12/57 Pt. Allotment, dated 07<sup>th</sup> March, 2015 **Smt. Reena Sharma, Secretary to Hon'ble Judge**, High Court of M.P., Jabalpur is allotted High Court Pool Quarter No. "G-414" in place of Quarter No. "G-416", Shankar Shah Nagar, Jabalpur, for her residence on following terms & conditions, :-

- 1 If, she fails to occupy the quarter, physically, within a period of seven days from the date of present order, then the allotment of the Govt. accommodation shall stand cancelled.
- 2 If, it is found at any time that she herself not living in the allotted Govt. accommodation and instead permitted to occupy the same to some other party, then the allotment of accommodation shall be cancelled immediately.
- 3 In any case & under any circumstances, sub-letting of the allotted Govt. accommodation will not be allowed.
4. If, it is found, at any time, that she owns residential house within the limit of Municipal Corporation, Jabalpur either in her name or in the name of any member of her family, prior to taking over or after taking over of the occupation of the allotted Government Residential Accommodation, then the allotment of such accommodation shall be cancelled immediately.


