- 1 If, he refuses to occupy the Govt. accommodation allotted to him, his name will be deleted from waiting list;
- 2 If, he fails to occupy the quarter, physically, within a period of seven days from the date of present order, then the allotment of the Government accommodation shall stand cancelled;
- 3 If, it is found at any time that he himself is not residing in the allotted Govt. accommodation and instead permitted to occupy the same to some other party, then the allotment of accommodation shall be cancelled immediately;
- 4 In any case & under any circumstances, subletting of the allotted Govt. accommodation will not be allowed;
5. If, it is found, at any time, that he owns residential house in the limits of Municipal Corporation, Jabalpur, either, in his name, or in the name of any member of his family, prior to taking over or after taking over the possession of the allotted Government Residential Accommodation, then the allotment of Government accommodation shall be cancelled immediately.
