- 3- That, the Law Clerk-cum-Research Assistants who wants to leave the assignment before the expiry of the assignment session shall be required to give one month prior notice in writing through Secretary of Hon'ble Judge with whom she attached as Legal Assistant/Law Clerk-cum-Research Assistant.
- 4- That, the Legal Assistant/Law Clerk-cum-Research Assistant shall maintain devotion to duty and a highest standard morality during the term of assignment and will not accept any other assignment during the term of assignment. Further, she shall not practice as an Advocate any Court of Law or attend Lawyers office during the course of assignment session as Legal Assistant/Law Clerk-cum-Research Assistant.

- 5- The Legal Assistant/Law-cum-Research Assistant shall furnish an undertaking as per Schedule-II of the Scheme for engaging Legal Assistant/Law Clerk-cum-Research Assistant in the High Court of Madhya Pradesh, 2022.
- 6- The candidate shall join her duty at respective place of posting positively by 24-06-2023, failing which their appointment shall be treated as cancelled.
