**Shri Sumit Kumar Soni, Junior Judicial Assistant, S/o Late Shri Rajesh Narvariya, Junior Judicial Assistant, High Court of M.P., Jabalpur, is allotted High Court Pool Quarter No. "H-578", Beohar Bag, Jabalpur** (presently possessed by his mother Smt. Nidhi Soni), in the light of Order No. F-1-25/2013//II-A (3), dated 11/09/2014 and point no. 11 of Order No. F-01-03/2013//II-A(3), dated 04/10/2013 of Govt. of M.P., Home (General) Department, Bhopal, for his residence on following terms & conditions :-

1. If, he fails to occupy the quarter, physically, within a period of seven days from the date of present order, then the allotment of the Government accommodation shall stand cancelled;
2. If, it is found at any time that he himself is not living in the allotted Govt. accommodation and instead permitted to occupy the same to some other party, then the allotment of accommodation shall be cancelled immediately;
3. In any case & under any circumstances, subletting of the allotted Govt. accommodation will not be allowed;
4. If, it is found, at any time, that he owns residential house in the limits of Municipal Corporation, Jabalpur, either in his name, or in the name of any member of his family, prior to taking over or after taking over the possession of the allotted Government Residential Accommodation, then the allotment of such accommodation shall be cancelled immediately.
