Archana Barkade, the then Judicial Assistant), High Court of M.P., Jabalpur, on following terms & conditions, :-

1. If, he fails to occupy the quarter, physically, within a period of seven days from the date of vacation of High Court Pool Quarter No. "H-85", then the allotment of the Govt. accommodation shall stand cancelled.
2. If, it is found, at any time that he himself is not living in the allotted Govt. accommodation and instead permitted to occupy the same to some other party, then the allotment of accommodation shall be cancelled immediately.
3. In any case & under any circumstances, subletting of the allotted Govt. accommodation will not be allowed.
4. If, it is found, at any time, that he owns residential house in the limits of Municipal Corporation, Jabalpur, either in his name, or in the name of any member of his family, prior to taking over or after taking over of the occupation of the allotted Government Residential Accommodation, then the allotment of such accommodation shall be cancelled immediately.
