In supersession of this Registry Order No. D/2475/V-3-12/57 Pt.IX (Allotment), Jabalpur, dated 09th April 2019 Smt. Roshni Singh Patel, Personal Assistant, High Court of M.P., Jabalpur is allotted High Court Pool Quarter No. "G-381" in place of Quarter No. "G-397", Shankar Shah Nagar, Jabalpur, for her residence on following terms & conditions, :-

1. If, she fails to occupy the quarter, physically, within a period of seven days from the date of present order, then the allotment of the Govt. accommodation shall stand cancelled.
2. If, it is found at any time that she herself is not residing in the allotted Govt. accommodation and instead permitted to occupy the same to some other party, then the allotment of accommodation shall be cancelled immediately.
3. In any case & under any circumstances, subletting of the allotted Govt. accommodation will not be allowed.
4. If, it is found, at any time, that she owns residential house in the limits of Municipal Corporation, Jabalpur, either in her name, or in the name of any member of her family, prior to taking over or after taking over of the occupation of the allotted Government Residential Accommodation, then the allotment of such accommodation shall be cancelled immediately.
