In light of the Notification issued u/s 20(B) of the Specific Relief (Amendment) Act, 2018 (No. 18 of 2018) by Government of M.P. Department of Law & Legislative Affairs, Bhopal no. 17(E)/02/2019/21-B(1)/103/19 dated 30-01-2019, Hon'ble the Acting Chief Justice has been pleased to direct that the Special Court at Bhopal shall exclusively deal with the cases relating to Infrastructure Projects for first two days in the first three weeks of every month & that of the Special Court at Satna shall exclusively deal with the cases one day in first three week of every month & for the remaining days they shall discharge their regular Judicial work .
