In exercise of the powers conferred u/s 11(2) of the Code of Criminal Procedure, 1973 (Act no. 2 of 1974) and all other enabling provisions, the Judicial Magistrate First Class specified in column no. (2) is hereby designated to deal with the cases in respect of offences relating to **VYAPAM** Scam matters and other matters linked thereto, investigated by the Central Bureau of Investigation, by Special Task Force or by Local Police Stations for area specified in the corresponding entries in column no. (4) thereof. The Headquarter of the Courts will be at the places mentioned in column no. (3).

This Notification is being issued by making partial amendment in Notification No. A/1919 dated 21.04.2022 and C/2464 dated 29.02.2024 issued in this regard in respect of designating Court of Judicial Magistrate First Class, Jabalpur for dealing with cases in respect of offences relating to VYAPAM Scam matters for the places mentioned in the following table.
