The designated Courts of Additional Sessions Judges are hereby also notified as Courts as specified under section 153(2) of the Electricity Act, 2003 and under section 36(2) of the NDPS Act, 1985 for trial of cases filed against the elected Members of Parliament and Members of Legislative Assembly, former or sitting, in the State of Madhya Pradesh.

The Headquarter of the Special Courts and their respective jurisdiction will be as detailed in the table.

This notification is issued by making amendment in earlier notification(s) No. B/8125 dated 14.12.2021 and A/4547 dated 23.11.2022 issued by the High Court of M.P. in this regard.
