NOTIFICATION

In relation to advertisement No. 79/Exam/DRHJS/2023 dated 22.08.2023, it is to notify that the objections/representations received against proposed Model Answer Keys of Online Preliminary Examination of District Judge (Entry Level) Direct Recruitment from Bar, Exam-2023, held on 03.12.2023, which were invited by way of Notification No. 124/Exam/DRHJS/2023, dated 03.12.2023, have been duly considered. After consideration, it has been decided to delete the Q.No. 23, 67, 68 & 85 and the result of Online Preliminary Examination has been prepared on the basis of valuation of the remaining 146 questions. Accordingly, now the candidate of U.R. & O.B.C. category will have to secure minimum 60% marks (87.6 round off 88 marks, out of 146 marks) and candidate of S.C. & S.T. category will have to secure minimum 55% marks (80.3 marks, round off 80 marks, out of 146 marks). Objections to the remaining questions have been rejected.

The category-wise cut-off-marks and number of candidates qualified for Main Written Examination are as given below:-

Candidates who have been found <u>successful</u>, to apply for the Main Written Examination, are directed to submit their duly filled Application Form along-with self attested copies of relevant documents by mentioning the name of post at the top of the envelope with **Examination Section**, Administrative Building, High Court of M. P., Jabalpur (M.P.), Pin Code-482001 through Receipt Section, High Court of M.P. Jabalpur (M.P.), Pin Code-482001 (through post or by hand) <u>on or before 24.01.2024</u>.

The duly filled Application forms with documents must reach the Examination Section of the High Court within the prescribed time. Duly and correctly filled Application Form(s) shall be treated as valid, while incomplete Application Form or Application Form with incorrect particulars will not be considered to be valid. No correspondence shall be entertained in this regard and the same shall be filed without assigning any reason.

In case, Application Form of any candidate is not received within prescribed time mentioned above, for whatsoever reason i.e. even postal delay, will not be accepted as an excuse for late submission of Application Form and application received after last date shall be summarily rejected without assigning any reason.

Candidates can view their marks of Online Preliminary Examination approximately after one week from declaration of result by login on www.mphc.gov.in by using their ID (Online Application No.) and password.
