**NOTIFICATION**

**Civil Judge Class-2 (Entry Level) Exam-2015**

Pursuant to the direction contained in order dated 22.01.2016 in Writ Petition No.1224/2016 and Writ Petition No.1281/2016 petitioners and other similarly placed 62 candidates were permitted to appear in the main examination and again by interim order dated 10.05.2016. Hon'ble the High Court of Madhya Pradesh in above mentioned both writ petitions have permitted petitioners and similarly placed candidates to appear in the interview if found successful, subject to the final decision of the above mentioned both writ petitions.

Hon'ble the High Court by order dated 15.06.2016 has dismissed the above mentioned both writ petitions with a direction that "*the benefit granted to the petitioners to participate in the second phase of the selection process by virtue of the interim order stands vacated. They are also not entitled to participate in the second phase of the examination and therefore, their result be cancelled*".

Pursuant to the direction contained in final order dated 15.06.2016 result of petitioners and similarly placed 62 persons is cancelled. Consequently, as per list ported on the Madhya Pradesh High Court official website 13 candidates including petitioner are now not-eligible for interview.

Consequent, upon the final order dated 15.06.2016 in place of above 13 candidates who were earlier successful for interview by court order, Roll Number-wise Additional List of successful candidates is being ported on the official website of the Madhya Pradesh High Court ([www.mphc.in](http://www.mphc.in)).
