Similarly, in Question No.56 of English version correct Answer is Option 3 while in Hindi version correct Answer is Option 1, hence candidates who have opted for either Option 1 or Option 3 both shall be awarded 1 mark.

The candidates declared Successful for Applying for Main Examination shall submit Applications, after filling the given format, to the Exam Cell, alongwith Self Attested copies of relevant documents, so as to reach the same in the Exam Cell on or before 13.06.2017 positively. Application for Main Exam received after stipulated time shall not be considered on any ground even on the ground of postal delay and shall stand cancelled and such candidates shall not be entitled to appear in the Main Written Examination.

Main Examination shall be held on 01.07.2017 (Saturday) & 02.07.2017 (Sunday) in two shifts from 09:30 a.m. to 12:30 p.m. (1st Shift) and 02:30 p.m. to 05:30 p.m. (2nd Shift), respectively at Jabalpur.
