Applications are invited for 31 **vacant post** in the cadre of Madhya Pradesh District Judge (Entry Level) through Suitability Test-2019 from amongst eligible Senior Division Civil Judges (Class-I) of State of Madhya Pradesh, under Rule-5(1) (a) of M.P. Higher Judicial Service (Recruitment and condition of service) Rules 2017, in the pay scale of Rs. 51550-1230-58930-1380-63070 (As amended time to time).

Promotion to this post and conditions of service will be strictly governed by the M.P. Higher Judicial Service (Recruitment and conditions of service) Rules 2017.

1. Eligibility:-

Only those Senior Division Civil Judges (Class-I) of Madhya Pradesh, whose names are figured in the annexed list (**Annexure – “A”**), shall be eligible to apply for the Examination.

The list of such eligible Senior Division Civil Judges (Class-I) is available on the website of M.P. High Court (www.mphc.gov.in).

2. Application :-

The eligible Senior Division Civil Judges (Class-I) desirous to appear in Examination will have to submit online application on the website of MP High Court (www.mphc.gov.in), on or before 21-08-2019.

Procedure and Direction for submitting Online Application Form :-

Candidates are required to log on website of www.mphc.gov.in and to click on “Recruitment/Result” Option, then click “Online Application form for Suitability Test-2019”, after filling of required information on the Application Form, you have to click on “browse” button to upload recent Color Photo and Signature (only in *jpeg* format). Before clicking

on "browse" button candidates are required to scan photo and signature in the given format and save in a document file from where the photo and signature so scanned can be browse and uploaded. After filling the form you have to click on Submit Button for final submission, then check the preview of Application Form, if you find all information are correct then click on submit button otherwise click on reset button to rectify that.

- Notes:-**
1. Candidates are required to read all information carefully before final submission of Application Form there shall be no provision to correction after final submission.
 2. Candidates are advised to keep with him/her a printout of the finally submitted application/form.

3. Disqualifications :-

In any of the following cases, the Judicial Officer/candidate for afore-said examination shall be disqualified and/or Departmental action for misconduct may be initiated against him:-

- (i) If he or she takes or attempts to take any favour in any form at any stage of examination, or
- (ii) Impersonation by or for the candidate, or
- (iii) Making or submitting any forged document in support of his or her candidature, or
- (iv) If he or she conceals any material information or provides any false information at any stage of selection process, or
- (v) If he or she uses or attempts to use, improper or illegal means, either for purpose of being permitted to appear in examination or at any stage of examination in examination room/hall, or
- (vi) If he or she, during written examination harasses or threatens or causes physical injury to or misbehaves with, any Officer or employee engaged there, or
- (vii) If he or she, disobeys any directions relating to examination including oral directions by the invigilator or observer or any other Officer or employee engaged in conduction of examination.

Moreover, Canvassing in any form will also be tantamount to disqualification. Similarly, any attempt on the part of a candidate to enlist support for his candidature or selection/appointment, through persons of influence or officers of Government/High Court will also disqualify him for appointment.

4. Travelling Expenses –

Travel expenses or allowances to the Senior Division Civil Judges (Class-I) appearing in aforesaid examination, will be payable as per Rules in the same way as he was travelling on official duty.

5. Call Letters :-

Admit Cards/Hall Tickets shall be generated by MP High Court on its website (www.mphc.gov.in) and the candidate shall download and may take a print-out of Admit Card. It shall be ensured that Admit Cards are generated by MP High Court atleast 10 days prior to the date of Examination.

Admit Cards/hall Tickets will be issued only to those candidates / Senior Division Civil Judges (Class-I) who have submitted their application forms complete in all respect within prescribed period. The Senior Division Civil Judges (Class-I) who fails to submit application form within prescribed period shall be tantamount their non- willingness to appear in suitability test, 2019.

6. Date, Time & Venue of Examination -

There shall be Written Examination, which shall be held on 21-09-2019 (Saturday) at 11:00 am to 2:00 pm (3 hours). The examination may be held at High Court Campus, at Jabalpur under the Control and Guidance of Principal Registrar (Exam).

7. Syllabus & Pattern of Question Papers -

There shall be two Question Papers containing 150 questions in total and each question shall carry 1 mark. Both the question papers shall be given simultaneously to the candidates. The first paper shall be MCQ (objective) type containing 100 multiple choice questions (Objective Type) whose answer has to be given on OMR sheet provided by the examination cell. In Second question paper, there will be 50 subjective questions whose answers will be confined up-to one line, for which space itself provided in the second question paper. Meaning thereby, the second question paper itself will be used as answer sheet also. The Subjects/ syllabus of suitability examination shall be as under: -

- A- Code of Civil Procedure, 1908.**
- B- Limitation Act, 1963 - Section 3, 5 to 14, 27 & 29 Articles 64, 65 & 137.**
- C- Specific Relief Act, 1963 - Chapter I - Section 5, 6, 7, & 8 Chapter VI - Section 34 & 35, Chapter VIII- section 38 & 41.**
- D- Motor Vehicle Act, 1988 - Section 140. 163-A and 166.**
- E- Code of Criminal Procedure, 1973.**
- F- Indian Evidence Act, 1872.**
- G- Indian Penal Code, 1860.**
- H- Negotiable Instrument Act, 1881 - Section 138 to 142.**
- I- The Electricity Act, 2003.**
- J- Translation- Hindi to English.**

8. Objections & Finalization of Model Answers -

After completion of Examination, the proposed Model Answers/Keys intended to be used for result of OMR sheets used for 1st Paper, shall be uploaded/published on the website of the M.P. High Court with the Notice to

the effect that if any candidate wishes to make any objection/clarification etc. regarding any Model Answer/Key, he /she may submit objection/clarification in writing & signed by him to the Principal Registrar (Exam) M.P. High Court, Jabalpur, within 7 days from the date of uploading/ publication of the proposed Model Answers/ Keys, by mentioning his /her Name along with self attested photo copies of source document(s)/ proof, which is/are base of his objection/clarification raised.

Objections/clarification received in aforesaid manner and mode within aforesaid time limit along with self-attested copies of the source/proof document shall be considered and the model Answers shall be finalized by the committee of Senior Judicial Officers/Registry Officers constituted by Hon'ble the Chairman of the Examination Committee. The Model Answer finalized by the committee, so constituted, will be put up before Hon'ble the Examination Committee and after being approved by Hon'ble the Examination Committee. The approved model answer shall be handed over to the Principal Registrar (Exam) and such finalized model answer shall be used as Keys/model Answers for the generation of result/valuation of the OMR sheets of the candidates. After declaration of result, no representation regarding any objection/clarification of any model Answers/questions, shall be entertained on any ground and shall be rejected without assigning any reason.

9. Valuation of 1st Question Paper –

After Examination the valuation of 1st Paper shall be made by OMR Scanner and shall be completed without delay.

10. Valuation of 2nd Question Paper –


Valuation of answer books of 2nd Paper shall be made by Central Valuation Method as per approved scheme. There shall no provision of revaluation of answer-books and any application from any candidate for revaluation, if received, shall stand rejected without assigning any reason.

11. Passing Marks-

Every Civil Judge who is an aspirant for promotion under rule-5(1)(a)(mentioned in list separately) shall have to secure a total of 45% marks in written examination to pass Suitability Test.

12. Final Result –

The Result shall be ported on the Website and shall also be affixed on the Notice Board of M.P. High Court. Marks List of the candidates may also be ported on the Website of M.P. High Court (www.mphc.gov.in).
