Applications are being invited for **11 vacant post** in the cadre of Madhya Pradesh District Judge (Entry Level) through Limited Competitive Examination from amongst Eligible Senior Civil Judges (Class-I) of State of Madhya Pradesh, under Rule-5(1)(b) of M.P. Higher Judicial Service (Recruitment and condition of service) Rules 2017, in the pay scale of Rs. 51550-1230-58930-1380-63070.

Promotion to this post and conditions of service will be governed by the M.P. Higher Judicial Service (Recruitment and conditions of service) Rules 2017.

It is made clear that in case no suitable candidate is found, unfilled vacant post shall be filled up according to proviso to Rule 5(1)(b) of M.P. Higher Judicial Service (Recruitment and Conditions of Service) Rules, 2017.

1. Eligibility :-

Only Civil Judges Class-I of Madhya Pradesh, who are to **complete Five Years of their tenure as Civil Judge Class-I on or before date of Examination** shall be eligible to apply for this Examination.

The List of such eligible Civil Judges Class-I is available on the website of M.P. High Court (www.mphc.in).

2. Application :-

The Eligible Civil Judge desirous to appear in this Examination will have to submit online application on the website of MP High Court (www.mphc.gov.in), on or before the **01-06-2018**.

Procedure and Direction for submitting Online Application Form :-

Candidates are required to log on website of www.mphc.gov.in and to click on “Recruitment/Result” Option, then click “Online Application Form for LCE-2018”, after filling of required information on the Application Form later on you have to click on “browse” button to upload recent Color Photo and Signature (only in *jpeg* format). Before clicking on “browse” button candidates are required to scan photo and signature in the given format and save in a documentary file from where the photo and signature so scanned can be browsed and uploaded. After filling the form you have to click on Submit Button for final submission, then check the preview of Application Form, if you found all information are correct so click on submit button otherwise click on reset button to rectify that.

Notes :- 1. Candidates are required to read all information carefully before final submission of Application Form there shall be no provision to correction after final submission.

1. Candidates are advised to keep with him/her a printout of the finally submitted form.

3. Disqualifications :-

In any of the following cases, the Judicial Officer/candidate for aforesaid examination shall be disqualified and/or Departmental action for misconduct may be initiated against him:-

- (i) If he or she takes or attempts to take any favour in any form at any stage of Examination, or
- (ii) Impersonation by or for the candidate, or
- (iii) Making or submitting any forged document in support of his or her candidature, or
- (iv) If he or she conceals any material information or provides any false information at any stage of selection process, or

- (v) If he or she uses or attempts to use, improper or illegal means, either for purpose of being permitted to appear in Examination or at any stage of Examination in Examination room/hall, or
- (vi) If he or she, during written Examination harasses or threatens or causes physical injury to or misbehaves with, any Officer or employee engaged there, or
- (vii) If he or she, disobeys any directions relating to Examination including oral directions by the invigilator or observer or any other Officer or employee engaged in conduction of Examination.

Moreover, Canvassing in any form will also be a disqualification. Similarly, any attempt on the part of a candidate to enlist support for his candidature or selection/appointment, through persons of influence or officers of Government/High Court will also disqualify him for appointment.

4. Travelling Expenses –

Travelling Expenses or allowances to the Civil Judge appearing in aforesaid examination, will be payable as per Rules in this respect in the same way as he was travelling on official duty.

5. Call Letters :-

Admit Cards/Hall Tickets shall be generated by MP High Court on its website (www.mphc.gov.in) and the candidate shall receive the same by downloading and taking print-out of Admit Card. It shall be ensured that Admit Cards are generated by MP High Court about 10 days prior to the date of Examination.

Call letter shall be issued only to those candidates / Civil Judges Class-I who have Submit their application forms and other Civil Judges Class-I shall be considered as not willing to appear in the Limited Competitive Exam.

6. Scheme, Date, Time & Venue of Examination –

There shall be Written Examination comprising of Two Papers, that may be **held on date 01/07/ 2018 (Sunday)** at time mentioned below -

1st Paper	Time – 10:00 a.m. to 12:00 p.m.
2nd Paper	Time – 02:00 p.m. to 05:00 p.m.

Venue of Examination

The examination may be held at High Court Campus, at Jabalpur under the Control and Guidance of Principal Registrar (Exam).

1st Question Paper – There shall be 100 Objective type questions in this Question Paper. Hundred Question of the question paper finalized for the Preliminary Examination of M.P. Note- (1) Current/leading cases shall be based on JOTI Journal 2014, 2015 & 2016.

(2) For summarization same matter shall be given in both language and the candidate shall have to attempt any of them.

(3) Judgment shall be either of Criminal Case or of a Civil Case and shall be attempted starting with charge/issues stage.

(4) Evaluation of Judgment shall be divided as under-
Charge/issue-05 Marks,

Marshalling of evidence 05 marks,

Appreciation of Evidence and application of Law-15 Marks,

Findings and conclusion - 05 Marks.

- (5) Order shall be either of Criminal Case or of a Civil Case.
 (6) For Settlement of issues/framing of charge matter shall be given opposite to the nature of matter given for Judgment writing.

It may be made clear to the candidates that the quoting of principle of any citation would be enough and quoting of citation shall not carry any extra weightage. Further the quoting of wrong citation may be detrimental to the candidate.

8. Valuation of 1st Question Paper –

After Examination the valuation of 1st Paper shall be made by OMR Scanner and shall be completed without delay.

9. Valuation of 2nd Question Paper –

Valuation of Answer Books of 2nd Paper shall be made by **Central Valuation Method** as per approved scheme. **There shall not be any provision for making Application for revaluation of Answer-books** of any candidates and any application for revaluation, if received, shall stand rejected without assigning any reason.

10. Bench Mark: –

There shall be no Interview/Viva Voce. However, **in place of Interview/Viva Voce**, Past Performance and Reputation shall be considered. For consideration of Past Performance there shall be **50 marks on basis of Bench Mark** of the Officer concerned, to be evaluated on following criteria, which shall form a part of the final result –

- Notes- 1-** Judgment of only those candidates securing 50% marks in total of Q.P.-1 & 2 shall be scrutinized.
- 2-** Every candidates/Judicial Officers appearing in this exam shall be asked to bring with him contested one judgment of civil case and one judgment of Criminal case passed by him before the date of advertisement and submit at exam centre on the date of examination.
- 3-** For computing marks of ACR's and Disposal of last five year, the following parameters shall be adopted-

- (i) For each year ACR Grade-wise mark shall be as under-

Grade	A+ or A	B	C	D	E
Marks	4	3	2	1	0

(ii) For each year Disposal Grade-wise mark shall be as under-

Per day average in units	9 or above	Very Good	Good	Average	Below average

In computing of disposal marks of last five year, disposal of last five years excluding the period where no Judicial work was assigned and the period of deputation, shall be taken into account.

- 4- For Consideration of Reputation Vigilance Report of concern Judicial Officers shall be sought from Vigilance Cell.
- 5- It is made clear that notwithstanding that a person has passed such Limited Competitive Examination, his suitability for promotion shall be considered by the High Court on the basis of his Past Performance and Reputation.
- 6- Only on the basis of passing of Limited Competitive Examination a Judicial Officer suo-motu shall have no right for promotion unless his Past Performance and Reputation is considered by High Court to be fit for promotion.

Minimum Marks.

A Candidate/Civil Judge, aspirant for promotion under Rule 5(1)(b) shall have to secure an aggregate of 50% marks (including the Bench Mark) for being declared successful.

Result /Select List-

As the aforesaid process is over, **the Result** shall be prepared as early as possible Roll No. wise Marks List, Merit wise Marks List and Select List shall be prepared. **After Preparation of the Result, the Result and Select List shall be put up before the Hon'ble Full Court of the High Court for its approval** and after approval thereof, the approved Final Select List and Result shall be published on the website of the M.P. High Court.

Elimination of Exam materials-

The used Examination material shall be eliminated after expiry of One year from the date of declaration/publication of the Result/ Provisional Select List.
