Applications are being invited for selection of Faculty for Physical Fitness Training as Visiting Faculty in the M.P. State Judicial Academy, Jabalpur. They will be paid remuneration at the rate approved by Hon'ble the Chief Justice i.e. Rs. 750/- per session of two hours. Therefore, no contractual or temporary nature of service is involved.

Selection of faculty from the faculty pool and requirement of faculty would be on the sole discretion of Director, State Judicial Academy. The faculty cannot claim to be deputed for a particular course or for a particular time span.

1. Qualifications :-

Candidates must have Degree/Diploma in P.E. (Physical Education) from any recognized University/College/Institution.

2. Application :-

The Eligible candidates desirous to appear in this Selection will have to submit an application in the given format. On the envelope, it would be specifically mentioned that "*Application for Faculty for Physical Fitness Training in M.P.S.J.A.*" which must have been received on or before the last date mentioned herein.

Last date for receiving the application is 27-10- 2016
(Thursday) till 5:00 p.m.

The application in format given with this Advertisement on the website of High Court, must be sent to the Principal Registrar (Exam), Administrative Building, High Court of M.P., Jabalpur (M.P.) mentioning on the top of the envelop "*Application for Faculty for Physical Fitness Training in M.P.S.J.A.* ", in such a manner that the same must have been received in Examination Cell on or before 27-10-2016 till 5:00 p.m.

3. Disqualifications :-

In any of the following cases, the candidate for aforesaid selection shall be disqualified :-

Signature

- (i) If he or she takes or attempts to take any favour in any form at any stage of selection, or
- (ii) Impersonation by or for the candidate, or
- (iii) Making or submitting any forged document in support of his or her candidature, or
- (iv) If he or she conceals any material information or provides any false information at any stage of selection process, or
- (v) If he or she uses or attempts to use, improper or illegal means, either for purpose of being permitted to appear in Interview or at any stage of selection in Interview room/hall, or
- (vi) If he or she, during Interview harasses or threatens or causes physical injury to or misbehaves with, any Officer or employee engaged there, or
- (vii) If he or she, disobeys any directions relating to Interview including oral directions by the Officer or employee engaged in conduction of Interview.

Moreover, Canvassing in any form will also be a disqualification. Similarly, any attempt on the part of a candidate to enlist support for his candidature or selection/appointment, through persons of influence or officers of Government/High Court will also disqualify him for appointment.

4. Call Letters :-

Application Form alongwith the documents so received in the examination cell, shall be scrutinized by the staff and list of all eligible candidates shall be prepared. The list so prepared shall be ported on website of M.P. High Court. Applications and documents received after prescribed time/ date shall not be considered, even on the ground of postal delay. Call Letters shall be issued to eligible candidates by Speed Post at the address given in their application forms.

6. Selection Process -

There shall be an Interview of 50 marks. Interview may be held at High Court Campus, at Jabalpur

7. Final Select List -

After Interview merit wise a panel of faculty for Physical Fitness Trainer will be prepared and the same shall be ported on website of M.P. High Court as well as affixed on notice board of the High Court (Exam Cell). Final lists shall be forwarded to the Director, M.P.S.J.A. for further action in the matter.

8. Destruction/disposal of Used Examination materials :-

After one year of the final result the record of the examination shall be eliminated.
