In continuation of Advertisement No. 325 dated 05.09.2020 and in addition to the list of candidates declared successful for Mains written examination vide notification no. 35/Exam/CJ/2019 (Phase-II) dated 24.05.2021, this is notified that in compliance of Order dated 14.07.2021 passed by Divisional bench of Hon'ble High Court of M.P. in W.P. As a result of acceptance of the report of the Expert Committee, a fresh select list (additional) has been prepared in view of the ratio of the judgment dt 28.05.2012 passed by Hon'ble The Supreme Court in Civil Appeal No. 4794 of 2012 in the matter of Pallav Mongia vs. Reg. General Delhi High Court & Anr., and marks have been recomputed so as to prepare this additional list.

The candidates whose names had been originally included in the select list published vide notification dated 24.05.2021 have not been excluded and in addition to them following newly included candidates, by way of above process, are being permitted to appear in the Main Written Examination for the recruitment to the post of Civil Judge Class-II (Entry Level).

Newly included candidates are directed to submit their duly filled Application Form along-with self attested copies of relevant documents by mentioning the name of post at the top of the envelope with **Exam Cell, Administrative Building, High Court of M.P., Jabalpur, (M.P.) Newly included candidates are also being provided one-time facility of opting their "Exam City Preference" from amongst Jabalpur, Indore, Gwalior & Bhopal. Candidates are required to visit <https://mphc.gov.in/exam-details> and then login by using their application ID thereafter, an OTP will be sent on registered Mobile Number of the concerned candidate, by entering OTP, "Online Choice filling for City Preference" window will be opened in which Application Number of the Candidate, Name & Father's Name will be displayed, then Candidate(s)

have to opt their Exam City preference from the drop down list in Tab provided for the above purpose.

It is made clear that this facility is subject to availability of seat in opted Exam City & same shall be available for limited period from 10.08.2021 (12:00 noon) to 12.08.2021 (12:00 noon). Allotment of Exam City to candidates by the High Court of M.P. shall be final, and neither request regarding allotment of Exam City nor request for change of City/Center(s) through other mode, shall be entertained after lapse of above period. If any candidate does not avail above facility then he/she shall be accommodated at centre in Jabalpur City.

The time schedule of Main Written Examinations was declared and published for information to all stake holders vide notification No. 52 /Exam/ CJ/2019 (Phase-II) Jabalpur dt. 26.06.2021. Considering the number of newly included candidates and Administrative Exigency, the exam scheduled on 13th & 14th August, 2021 will be held on **28th & 29th August 2021** in two shifts each day.


