

HIGH COURT OF MADHYA PRADESH : JABALPUR**Scheme of Suitability Test-2017 of Civil Judges
(Sr. Division) for Promotion as District Judge (Entry Level)
(u/s Rule 5 (1)(a) of M.P. H.J.S. Rules, 1994****Venue-**

There shall be Written Examination, which shall be held on 13/08/2017 (Sunday) at 11.00 am to 2.00 pm (3 hours). The venue of Examination shall be High Court premises of Main seat Jabalpur.

Question Paper – (150 marks)

There shall be two Question Papers containing 150 questions in total and each question shall carry 1 mark. Both question papers shall be given simultaneously to the candidates. There shall be 100 Multiple choice questions (Objective Type) in First question paper & OMR sheet shall be used as Answer Sheets. In Second question paper there shall be 50 subjective questions and answer of each question shall be kept limited to one line left blank on the question paper itself. Thus the question paper itself shall be used as Answer Sheet also. The Subjects/ syllabus shall be as under : -


