In accordance with the provisions of Rule 7 (1) (A) (ii) of the said Rules 2006, a citizen/applicant is required to pay fee of Rs. 50/- in the form of Non-Judicial Stamp or Treasury Challan, pasted with self-attested photograph (in original) of the applicant on Form "A" and you have not filed the application in Form No. "A" and failed to affix/attest your photograph you have enclosed One India Non Judicial Stamp of amounting to Rs.20/- bearing no. 32AA 678844 which is being returned herewith, in original, to you.
2. As per Rule 8 (1) of the High Court of the MP (Right to Information) Rules, 2006 as amended, State Public Information Officer shall not be liable to provide any information which can be obtained under the Provisions of Chapter XVIII of the High Court of MP Rules, 2008. Hence, you are accordingly requested to contact Copying Section of this Bench Registry and apply for certified copies of the documents required by you after paying the proper Copying fee.
3. Request for providing a copy of judicial case under the provisions of the Right to Information Act specially can not be accepted when it can be provided under the copying rules.
4. This is to further inform you that the names of parties in O.A. No.713/1996 of Abolished M.P. Administrative Tribunal Bench Indore are (Dr. Rajkumar Singh Vs. State of M.P. through Principal Secretary, Government of M.P., Department of Medical Education Mantralaya, Bhopal and 3 Others) whereas as per your RTI application you have requested to supply you the copy of your petition registered in M.P. High Court, Indore - as O.A./713/1996, hence the names of the parties does not tally.
