But the information desired by you cannot be supplied due to the following reasons:-

1. The Competent Authority of High Court of M.P. has framed ‘High Court of M.P. (Right to Information) Rules 2006’ under Section 28 (1) of the Right to Information Act, 2005. In accordance with the provisions of Rule 7 (1) (A) (ii) of the said Rules 2006, a citizen/applicant is required to pay fee of Rs. 50/- in the form of Non-Judicial Stamp or Treasury Challan, pasted with self-attested photograph (in original) of the applicant on Form “A” and you have not filed the application in Form No. “A” and failed to affix/attest your photograph. You have enclosed One India Non Judicial Stamp amounting to Rs.50/- bearing no. BM 584586 which is being returned herewith, in original, to you.
2. As per Rule 8 (1) of the High Court of the MP (Right to Information) Rules, 2006 as amended, State Public Information Officer shall not be liable to provide any information which can be obtained under the Provisions of Chapter XVIII of the High Court of M.P. Rules, 2008. Hence, you are accordingly requested to contact Copying Section of this Bench Registry and apply for certified copies of the documents required by you after paying the proper Copying fee.
3. Request for providing a copy of judicial case under the provisions of the Right to Information Act specially can not be accepted when it can be provided under the copying rules.
4. As no clear and specified particulars of the information sought and details are not specified by you in the application as per Section 6 (1) (b) of the Right to Information Act, 2005.
5. This is to further inform you that you have failed to mention correct and specific number and names of the parties of your case, instead you have mentioned W.P. vide application No. O.A./71/1996 OR O.A./713/1996 and the names of the same are not tallied because the names of parties in O.A. No. 71/1996 are (Nurullah Sheikh Vs. The State of M.P. through District Collector, Khargone and 3 Others) whereas the

No. 71/1996 and O.A. No. 713/1996 of Abolished M.P. Administrative Tribunal Bench Indore are enclosed herewith for ready reference)
