Please refer to your application dt. 07.11.2021 received vide Inward Number 1963 dt.08.11.2021 and Registered at our I.D. No. 23/2021-2022 dt. 08.11.2021 addresed to the undersigned regarding supply of following information under Right to Information Act, 2005 as under:-

But the information desired by you cannot be supplied due to the following reasons:-

1. The Competent Authority of High Court of M.P. has framed 'High Court of M.P. (Right to Information) Rules 2006' under Section 28 (1) of the Right to Information Act, 2005. As per Section 19 of the Right to Information Act, 2005, you may file an appeal to the Appellate Authority (Principal Registrar, High Court of M.P., Indore Bench) within 30 days of the issue of this order.
