Please refer to your application dt. 07.11.2021 received vide Inward Number 1963 dt.08.11.2021 and Registered at our I.D. No. 23/2021-2022 dt. 08.11.2021 addressed to the undersigned regarding supply of following information under Right to Information Act, 2005 as under:-
