In accordance with the provisions of Rule 7 (1) (A) (ii) of the said Rules 2006, a citizen/applicant is required to pay fee of Rs. 50/- in the form of Non-Judicial Stamp or Treasury Challan, pasted with self-attested photograph (in original) of the applicant on Form "A" and you have not filed the application in Form No. 'A' and failed to affix/attest your photograph and instead of enclosing Indian Non Judicial Stamp of Rs. 50/- you have enclosed one Indian Postal Order of amounting to Rs. 10/- bearing no. 56F 569531 (Mentioning therein to pay to Hon'ble Administrative Judge, High Court of M.P., Bench at Indore) which is being returned herewith, in original.


