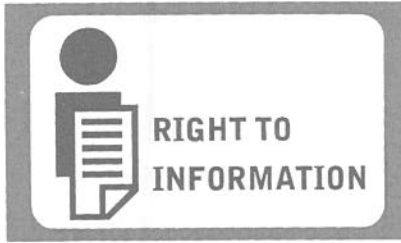

As per Hon'ble Court's order dated 05.04.2013 passed in F.A. No. 76/2012 (Prakashchandra Shah Vs. Rajkumar Agrawal deceased through L.Rs. Sudhir Agrawal & one another) the possession part of the decree is stayed till the decision of the appeal. The instant case is Admitted for Final Hearing and the same is updated in the following categories :-

- (i) "Civil – M.P. ACCOMODATION CONTROL ACT – BONAFIDE REQUIREMENT (at Sr. no. 30 and at Sr. No. 19023 in overall FH cases)" and
- (ii) (ii) Civil – CASES OF SENIOR CITIZEN (at Sr. No.: 3230 and at Sr. No.: 14088 in overall FH cases)".
