1. The Competent Authority of High Court of M.P. has framed 'High Court of M.P. (Right to Information) Rules 2006' under Section 28 (1) of the Right to Information Act, 2005. In accordance with the provisions of Rule 7 (1) (A) (ii) of the said Rules 2006, a citizen/applicant is required to pay fee of Rs. 50/- in the form of Non-Judicial Stamp or Treasury Challan, pasted with self-attested photograph (in original) of the applicant on Form "A" and you have not filed the application in form No. 'A' and failed to attest your photograph and instead of enclosing Indian Non Judicial Stamp of Rs. 50/- you have enclosed two Indian Postal Order of amounting to each Rs. 5/- bearing no. 60C 200400 & 60C 200379, total Rs.10/- which are being returned herewith, in original.

As per Section 19 of the Right to Information Act, 2005, you may file an appeal to the Appellate Authority (Principal Registrar, High Court of M.P., Indore Bench) within 30 days of the issue of this order.
