(a copy of blanked FORM – “A” is enclosed herewith for ready reference)
2. As per Rule 3 (2) of the High Court of M.P. Rules, 2006 every application shall be made for one particular item of information only whereas multiple information have been sought by you.
3. The information required by you is not under the purview of the ‘Information’ defined u/s 2 (f) of the Right to Information Act, 2005. SPIO is not supposed to answer the query/question.




