2. As per Rule 3 (2) of the High Court of M.P. Rules, 2006 every application shall be made for one particular item of information only whereas multiple information have been sought by you.
3. The information sought under RTI Act 2005 is required to be very specific and precise, so that, the Authority may conveniently supply the information after



ascertaining, if the same may be disclosed under the provisions of Sections 8 & 9 of the RTI Act 2005. You have not disclosed the case number, name of Hon'ble the Judge & Bench which passed the said Judgement/order.

5. Request for providing a copy of judicial case under the provisions of the Right to Information Act specially can not be accepted when it can be provided under the coping rules.

**As per Section 19 of the Right to Information Act, 2005, you may file an appeal to the Appellate Authority (Principal Registrar, High Court of M.P., Indore Bench) within 30 days of the issue of this order.**
