

In case, it does not fall under your jurisdiction, the same be further transferred to the concerned Public Authority under intimation to the applicant.

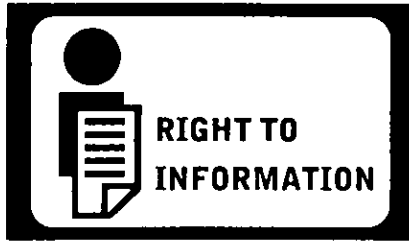
