

In the copy endorsed to the Principal Registrar/SPIO, High Court of M.P., Bench the following request for information has been made by you:-




But the information desired by you cannot be supplied due to the following reasons :-

- (1) As per Rule 3 (1) of the High Court of M.P. Rules, 2006 every application shall be made for one particular item of information only whereas multiple information have been sought by you.
- (2) As per Rule 8 (1) of the High Court of the MP (Right to Information) Rules, 2006 as amended, State Public Information Officer shall not be liable to provide any information which can be obtained under the Provisions of Chapter XVIII of the High Court of MP Rules, 2008. Hence, (Certified Copy of Ordinance No.16 sought by the applicant as per contents of Para No. 7 of the order dated 17.01.2018 passed in W.P.No.5839/2017 cannot be provided under RTI Act, as the same may be obtained by the applicant from Head Copyist as per Chapter XVIII of the High Court of M.P. Rules, 2008 after paying Copying Fee as per rules). You are accordingly requested to contact Copying Section of this Bench Registry. This is worthnoting here that earlier also your RTI application I.D.no.04/2018-19 was rejected vide Rejection Order No. RTIA/DR-HCIND/921 DATED 07.05.2018 on the same ground alongwith other grounds.
- (3) The applicant is seeking queries/clarification/confirmation of Ordinance No.16 stating it to be imaginary document which cannot be made/replied within the meaning of information under Section 2(f) of the RTI Act. It is not the duty of the public authority to explain to any person the implications of Ordinance. The information provider cannot elicit the opinion on the correctness or otherwise of his impressions, and therefore, the undersigned cannot be expected to respond to this query.

As per Section 19 of the Right to Information Act, 2005, you may file an appeal to the Appellate Authority (Principal Registrar, High Court of M.P., Indore Bench) within 30 days of the issue of this order.


