Please refer to your application dt. 25.05.2018 received vide Inward No. 1340 dated 31.05.2018 & registered at our I.D. No. 15/2018-19 addressed to the undersigned regarding supply of information under Right to Information Act, 2005 as under: -

But the information desired by you cannot be supplied due to the following reasons:-

- (1) The competent Authority of High Court of M.P. has framed 'High Court of M.P. (Right to Information) Rules 2006' under Section 28(1) of the Right to Information Act, 2005. In accordance with the provisions of Rule 7(1) of the said Rules 2006, a citizen/applicant is required to pay fee of Rs. 50/- in the form of non-judicial stamp or Treasury Challan, pasted with self-attested photograph (in original) of the applicant on Form 'A' and you have not filed the application in form no. A and failed to attest your photograph and instead of enclosing Indian Non Judicial Stamp of Rs. 50/- you have enclosed one Indian Postal Order of amounting to Rs. 10/- bearing no. 42F 482484.
- (2) As per Rule 3 (1) of the High Court of M.P. Rules, 2006 every application shall be made for one particular item of information only whereas multiple information have been sought by you.
- (3) As per Rule 8 (1) of the High Court of the MP (Right to Information) Rules, 2006 as amended, State Public Information Officer shall not be liable to provide any information which can be obtained under the Provisions of Chapter



