INSTRUCTIONS TO THE BIDDERS:-

1. The last date of hard copy tender submission is 03rd January, 2024 before 04:30 P.M. and the technical and financial bids of the tender are to be opened on 04th January, 2024 at 11:30 A.M.
2. Interested firm may send their proposal in the name of Registrar General, High Court of Madhya Pradesh, Jabalpur in sealed envelope should cover superscribed as "Supply, Installation, Commissioning and Maintenance of Interactive Display Panel at Madhya Pradesh State Judicial Academy, Jabalpur as per Specification below" bid from: M/s -----" **“NOT TO BE OPENED BEFORE 11:30 A.M. on 04th January, 2024** which will be received as time mentioned in the Schedule of Events. The Bid is to be submitted to the “Inward / Receipt Section of the High Court of M.P., Jabalpur.
3. Any bid received after the time and date for receipt of bids prescribed in the tender may be rejected and returned unopened to the Bidder.
4. The Registrar General, High Court of Madhya Pradesh has all rights to accept or reject the tender at any time without assigning any reason.
5. The proposal should be submitted along with Earnest Money Deposit (EMD) of **Rs.5,000/- (Rupees Five Thousand Only)** in the format of Demand Draft valid for the period of 3 month in favour of “***Registrar General, High Court of Madhya Pradesh, Jabalpur***”. The Bid submitted without EMD shall be summarily rejected.

6. Experience in Supply, Installation, commissioning, Maintenance of Laptop Computers, Servers, Desktop Computers, Printers, UPS systems and other related IT Equipment's etc. during last 3 years ***(The vendor has to quote experience of minimum 03 years, in this regard, the work /purchase orders copies of three years is required from the bidder).***
7. The Bidder is required to provide on-site comprehensive warranty valid for **60 months** for Supply, Installation, Commissioning and Maintenance of Interactive Display Panel at Madhya Pradesh State Judicial Academy, Jabalpur from the date of installation.
8. The Successful Bidder will be required to furnish performance guarantee in the form of unconditional Bank Guarantee issued by a Nationalized / Scheduled Bank in India equivalent to **05%** of the Contract Value valid for a period of **62 months** within **30 days from the date of issue of Letter of Acceptance/ Purchase Order.** The Performance Guarantee shall be as per the format approved by the Registrar General, High Court of M.P., Jabalpur.
9. The successful bidder shall complete the assignment within 15 days from the date of issue of Letter of Acceptance / Purchase Order.
10. The Bidder shall, at the time of submitting the bid to submit the Technical Proposal specifying how the Bidder proposes to carry out repair under Warranty.

11. LIQUIDATED DAMAGES (LD):-

If the Bidder fails to deliver any or all of the equipment or to perform the services within the time period(s) as mentioned in tender document. Registrar General, High Court of Madhya Pradesh shall without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% of the contract price for every week (seven days) or part thereof of delay, up to maximum deduction of 10% of the contract price. Once the maximum is reached, Registrar General, High Court of Madhya Pradesh may consider termination of the contract.

12. FORCE MAJEURE:-

12.1 Neither party shall be responsible to the other for any delay or failure in performance of its obligations due to any occurrence commonly known as Force Majeure which is beyond the control of any of the parties, including, but without limited to, fire, flood, explosion, Acts of God or any governmental body, public disorder, riots, embargoes, or strikes, acts of military authority, epidemics, strikes, lockouts or other labour disputes, insurrections, civil commotion, war, enemy actions.

12.2 If a Force Majeure arises, the Bidder shall promptly notify the Registrar General, High Court of Madhya Pradesh in writing of such condition and the cause thereof. Unless otherwise directed by the Registrar General, High Court of Madhya Pradesh the Bidder shall continue to perform his obligations under the contract as far as is reasonably

practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. The Bidder shall be excused from performance of his obligations in whole or part as long as such causes, circumstances or events shall continue to prevent or delay such performance.

13. ARBITRATION:-

In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation hereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the Registrar General, High Court of Madhya Pradesh or his nominee. The sole arbitrator will be appointed by Hon'ble the Chief Justice, High Court of M.P. and the decision of the Arbitrator shall be final and binding on the parties. The arbitration shall be in Jabalpur and the Arbitrator shall give his award in accordance with "*The Arbitration and Conciliation Act, 1996*".
