2. All other terms and conditions for submission of tender are contained in this document. If the date of submitting/opening of the Bid is declared as holiday then the bids shall be submitted / opened on next working day.

**3. General Terms and Conditions:-**

- 3.1 All the items will be disposed off in one lot to the successful bidder and no part bids shall be entertained.
- 3.2 The bidders may inspect the items on the days given in the auction notice and satisfy themselves of the items that for they are bidding.
- 3.3 The items shall be sold / auction to the **Highest Bidder (H-1)**.
- 3.4 The Earnest Money Deposit (EMD) of the successful bidder shall be adjusted in the bid forthwith. The EMD of the unsuccessful bidder shall be returned, once the bid has been finalized without any interest. ***The firms registered under NSIC and MSME (The vendor to be registered with both NSIC and MSME for claiming exemption of tender fees) are exempted for submission of tender fees only. But they have to submit valid EMD as per the tender requirement.***
- 3.5 Items once disposed off to the successful bidders shall not be taken back by the Registrar General, High Court of Madhya Pradesh, Jabalpur under any circumstances whatsoever.
