

**Terms & Conditions :**

- 1- The offer/tender received via Fax/e-mail/telex & incomplete tenders will be summarily rejected.
- 2- Registrar General, High Court of MP, Jabalpur has absolute right to accept or reject any or all tenders in part or full without assigning any reason whatsoever or any notice.
- 3- Any conditions/terms given in the tender which is repugnant to tender document shall not be binding on the MPSJA.
- 4- Payment will be made only after satisfactory delivery of all the items and subject to availability of funds.
- 5- The rates quoted for supply of items is not subject to change in any condition, except change in GST or other taxes.
- 6- Bidders are required to furnish sample of each item along with their tenders. Rates of only those items will be considered which is supported by sample.
- 7- Tenders submitted without sample shall be rejected without assigning any reason.
- 8- Samples of unsuccessful bidders shall be returned after finalization of tender. Sample of successful bidder shall be kept by Academy for comparison.
- 9- Bidders shall be required to submit samples properly packed and marked so that they are distinctly identifiable.
- 10- The responsibility to take back the samples within 30 days of the finalization of tender process shall be of the bidders and Academy shall dispose of the samples after 30 days.
- 11- The quantity mentioned in the tender is indicative only and is subject to change as per requirement.
- 12- The award of contract shall be on the basis of qualitative assessment of product seconded by competitive pricing. Low price shall not be the sole criteria for award of contract.
- 13- The Purchaser reserves the right to procure any item from any vendor and it shall not be necessary to procure all items from single vendor.
- 14- The successful vendor has to submit performance guarantee in form of demand draft, drawn in favour of Registrar General, High Court of Madhya Pradesh of Rs.10,000/-. The performance



- guarantee shall be returned after termination of rate contract.
- 15- The successful vendor shall have to enter in rate contract with Director, Madhya Pradesh State Judicial Academy for supply of Wiro Binding Copies. The contract shall be valid for TWO YEARS which shall be subject to extension on mutual consent of both the parties.
- 16- The performance guarantee shall be seized in case of supply of inferior quality or in case of failure of supply.
