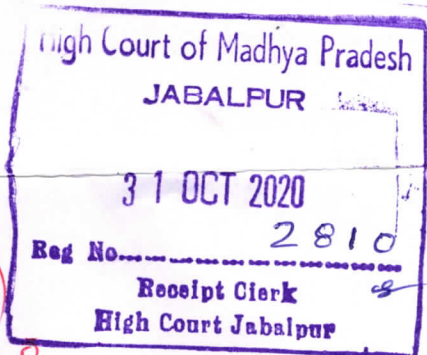
**OFFICE ORDER**


